A Credible Guide to Foreign Trade

The DPRK Chamber of Commerce is active in its business as a credible guide to trade and economic exchange and cooperation.

The Chamber of Commerce concluded agreements on cooperation with the chambers of commerce and industry in Slovakia, Croatia, Pakistan and Zimbabwe between July 2011 and June 2012, which constituted a legal basis for constantly promoting its external activities with foreign countries.

It made a tangible contribution to intensifying trade and economic exchange and collaboration with different countries of the world for the last one year through exchange of delegations, trade information campaign at the international expositions and trade fairs and various other activities.

It, first of all, has placed special emphasis on collaboration through the exchange of delegations to promote trade and economic ties, thereby facilitating socio-economic development both in the DPRK and in relevant countries.

In November last year it invited two times to the DPRK the delegations of European IT and clothing enterprises and organized working talks with its local trading partners, in which they agreed on consignment processing of various clothes, including 100 000 suits of men's clothes and 100 000 suits of

ordinary clothes a year. In October last year it invited French delegation of trade coordinating association that affiliates nine enterprises specializing in such fields as finance, metal, chemistry, city administration and hi-tech and organized business talks with its enterprises concerned in which they concluded agreements on mutual cooperation and also discussed the problems for their implementation.

In December last year and April this year it invited Chinese Jilin international joint venture association of minor enterprises and Zhejiang delegation of enterprisers respectively and organized inspection tours to Unjong science district, Taephyong district and other areas and, on this basis, discussed the matter of investment possibilities for developing those districts into high-tech goods production zone and industrial park.

Besides, it invited delegations from Russian Far East, Czech, Switzerland and other countries and discussed the issues relating to transaction of plate glass and lubricants, medical-treatment tourism and the distribution of fish-breeding techniques.

The Chamber of Commerce was also active in sending delegations to expositions and fairs held in other countries.

It arranged preparations for dispatching the delegations to the 10th Chinese international equipment

manufacturers' expo and the 11th Beijing international fair for process machines, building-materials machines and mining machines as well as meetings for exchange of technologies to conclude the agreements on exchange of equipment and technologies.

It had contacts with the Russian Chamber of Commerce and Industry and ensured that the Korea Jangsu Trading Corporation would export insam products to Russia and take part in the Moscow Health Food Exhibition, and established a well-knit system of advertising Kangso Mineral Water, insam products and other commodities of our country on the website of the Russian Chamber of Commerce and Industry on a regular basis.

Abundant Underground Resources and Policy of their Development

(A reporter of "Foreign Trade of the DPRK" had an interview with Kim Hung Ju, deputy director of a bureau of the DPRK Ministry of State Natural Resources Development.)

Reporter: I was told that in recent years the foreign investors' interest in natural resources of our country is on daily increase. I'd like to have a talk with you on some details of underground resources of the DPRK and its development policy.

Deputy director: As you know, our country is so rich in mineral resources that it is called a "mineral specimen room" of the world.

According to the geologists, Korean peninsula is endowed with a wealth of useful minerals that have been formed by magmatism and sedimentation caused by succession of big crustal movements.

Hundreds of kinds of minerals have been so far found in our country, of which useful minerals take large portion and they are in great deposits. There are lots of minerals needed for the development of the national economy, including iron and other ferrous metals, gold, silver, copper, lead, zinc, molybdenum and other nonferrous metals as well as magnesite, limestone, marble, etc.

Our country has also a wealth of rare earth, so called vitamin for industry, and fossil fuels such as anthracite, lignite, peat and ultraanthracite.

Indeed, our country is blessed with abundant underground resources and has a bright vista for their development, too.

Reporter: Would you please tell me about the DPRK policy on their development?

Deputy director: The DPRK Law on Underground Resources was adopted by the Decree No.14 at the Fifth Session of the Ninth Supreme People's Assembly on April 8, 1993 and amended and supplemented afterwards.

The law is intended to establish rigid discipline and order in survey, development and use of underground resources so as to expedite socialist economic construction and improve the people's standard of living.

The state ensures that survey of underground resources is put on a Juche-oriented, modern and scientific basis to prospect necessary underground resources in larger quantities and at a faster rate.

Today the development of underground resources in our country is posed as a very important matter in putting the production of all sectors of the national economy on a normal track.

Institutions, enterprises and organizations can develop underground resources. They are obliged not only to make mining equipment large, modern and high-speed and diversify transportation but to give priority to tunnelling and introduce efficient mining methods to boost the mineral output.

Development of underground resources is subject to the approval of the state organ of deliberation of underground resources development.

Institutions, enterprises and organizations engaged in underground resources development shall ensure

high efficiency of investment pursuant to the design of underground resources development.

They shall ensure rational organization of mining to excavate ore bodies that conform to mining criterion and standard of calculating deposits of underground resources. But the practices of digging out only high-grade and thick ore bodies in good condition to excavate are prohibited.

Abandoning of ore and coal mines and their pits should be subject to the approval of the state organ of deliberation of underground resources development.

Institutions, enterprises and organizations concerned should actively tap the resources of geotherm, underground water and mineral water necessary for the economic development and improvement of people's life.

The living environment of inhabitants and ecological environment of animals and plants, including land, resources and landscapes, should not be damaged in the course of their development.

The DPRK policy of underground resources development makes a tangible contribution to protection and development of underground resources to fully meet the increasing demands of the national economy for raw materials and fuel, and thus gives impetus to the building of a thriving socialist country.

A Giant Nonferrous Metal

The Komdok Mining Complex located in Komdok area with great deposits of lead and zinc ores is a leading nonferrous metal producer in the DPRK.



The complex composed of deep and upper sections has completed its pit structure with various sizes of shafts and equipped itself with up-to-date mining facilities.

Progress in Marine Transport

It is one of the fundamental questions arising in the development of foreign trade to promote forwarding business.

The DPRK government, attaching great importance to the promotion of forwarding business, marine transport in particular, in the development of foreign trade, has channelled every effort into it.

The DPRK is endowed with geographical advantages for forwarding business as most of its territory is sea-bound.

Given the conditions, it has long since paid close attention to building numbers of cargo ships and organizing trade fleets for the development of marine transportation.

According to its long-range plan, trade fleets were organized with cargo ships like "Wangjaesan" of 14 000 tons and "Taedonggang" of 20 000 tons in the 1970s on the basis of its independent shipbuilding industry, thereafter incorporating large cargo ships such as "Hyoksin", "Rungrado", "Kangson" and "Songrim" and oil tankers into the fleets.

The number of cargo ships is increasing considerably with the growth of shipment. They are assigned in an effective way to ensure the prompt loading of cargoes in keeping with the quotations of the chartering markets, thus further

enhancing efficiency of transportation.

It is of primary importance in developing marine transport to equip trade ports with the up-to-date facilities and raise their traffic capacity.

The DPRK government is building trade ports on an extensive scale in favourable places on the East and West seas of Korea and upgrading the existing ones.

Chongjin, Nampho, Hungnam and other trade ports were further modernized to meet the requirements of the developing reality, with the result that accommodation capacity of cargoes was increased and the loading and unloading equipment like wharf cranes were updated to raise the level of mechanization of harbour operations, thus enhancing the handling capacity of cargoes.

In recent years the reconstruction of the Rajin Port was pressed on. And the Tanchon Port on the East Sea of Korea took a facelift with the completion of construction of northern and southern breakwaters stretching about 2 000 metres long together with an office building, hall of culture, light tower, depots and other necessary facilities. At present, its cargo traffic capacity amounts to millions of tons.





Its construction provides advantageous conditions for export of nonferrous metals and magnesia products manufactured in Komdok and Tanchon areas.

Trade ports of the DPRK, which are transit points of trade cargoes and the direct undertakers of storage and shipment of cargoes and services for trade ships and their crew, made radical improvement in their management and operation so as to establish an orderly control system in accordance with the international law of the sea. Well-regulated system of training the crew was established and modern repair bases were set up in various places.

Today the DPRK witnesses the increase in the number of corporations specializing in marine cargo transportation and chartering of trade ships, including the Korea Ocean Maritime Management Co., Ltd., Korea Ocean Shipping Agency, Korea General Foreign Transportation Corporation and Korea Chartering Corporation.

The firm material and technical foundations of the marine transport of cargoes in the DPRK will make a great contribution to the development of its foreign trade.

According to clients' order it is building various kinds of vessels including large cargo vessels and repair them.






Marine propellers, jet orifices, anchors and anchor chains, pumps, electric motors, fittings and castings of various shapes and sizes are major export items of the corporation.



Mt. Ryongak, People's Cultural

The Ryongaksan Pleasure Park, located in the area of Ryongaksan, Ryongsan and Ryongbong dongs, has been splendidly rebuilt into a cultural recreation ground for the people.

A curiously-shaped rocky peak, a fine display of beautiful blossoms in full bloom in spring, dense forests in summer and glorious tints of foliage in autumn—all these are in perfect harmony with one another. Hence, from olden times it has been called "Mt. Kumgang in Pyongyang."

The mountain is, in the main, formed by such bed rocks as shale, siltstone and sandstone.

Summary of the Law on Foreign-Invested Bank

The DPRK Law on Foreign-Invested Bank was adopted by Resolution No.42 of then Standing Committee of the Supreme People's Assembly on November 24, 1993 and amended and supplemented in 1999 and 2002, respectively.

The law shall contribute to the expansion and development of cooperation with different countries the world over in the field of finance.

A foreign investor may establish and operate a foreign-invested bank within the territory of the DPRK.

Foreign-invested banks include joint-venture banks, wholly foreign-owned banks and branches of foreign banks.

The state shall protect the legal rights and interests of foreign-invested banks established in the territory of the DPRK.

An investor who intends to establish a foreign-invested bank in the territory of the DPRK shall file an application to the DPRK Central Bank, declaring the name of the bank, the name and curriculum vitae of its president, the registered capital, paid-up capital, operation fund, investment rate, details of business, etc.

The Central Bank shall decide upon the approval or rejection of the application within 50 days from its receipt.

A foreign-invested bank shall be dissolved when it cannot continue

its operation due to such reasons as the expiry of the term approved, merger of the banks, insolvency, defaulting of the contract and natural calamities.

A foreign-invested bank which obtained business license shall deposit the primary paid-up capital and operating capital in a bank designated by the Central Bank within 30 days from the date when it obtained the approval of its establishment and shall have it confirmed by a certified public accountant.

A joint-venture bank and a wholly foreign-owned bank shall set aside as reserve fund 5 per cent of its annual profits each year until the reserve fund grows 25 per cent of the registered capital, and a foreign-invested bank may reserve such funds in need as bonus fund, welfare fund and R&D fund.

A foreign-invested bank may engage in part or whole of such transactions as accepting deposits of foreign currencies of foreign-invested enterprises, foreign enterprises and foreigners, granting loans in foreign currencies, overdrafting on the current account, excess payment and discounting of foreign currency bills, dealing in foreign exchange, investment in foreign currencies, guarantee against liabilities in foreign currencies and defaulting of contract obligations, remittance

of foreign currencies, transactions of securities in foreign currencies, trust banking, credit survey and consultation.

A foreign-invested bank shall open an account at the branch of the Central Bank in the area where it is located and deposit the reserve fund for deposit payment.

A foreign-invested bank shall submit to the foreign exchange control organ the annual balance sheet and profit and loss account confirmed by a certified public accountant within 30 days from the date of the completion of the annual business settlement, and the quarterly financial statement and necessary statistics by the 15th day of the first month of the ensuing quarter of the year.

A foreign-invested bank shall be liable to fine in such cases as it has changed its president or vice-president or the location of the bank without approval; it has failed to set aside the reserve fund of required amount; it has obstructed or caused difficulties in inspection; and it has failed to submit regular reports within a fixed period of time, or submitted false ones.

In case an applicant for establishment of a bank fails to commence banking business within 10 months from the date of the approval, the approval granted for establishment of the bank may be withdrawn.
